**About this Program:**

In this new 15 hour course, professor and research expert Dr. Dan Murphy, D.C., DABCO will advocate optimizing structure and function through a poly-therapeutic intervention program that develops superior clinical outcomes. Dr. Murphy will succinctly drive home key concepts. Topics range from Chiropractic care, laser therapy, ATP, Mitochondrial function, diet, exercise, brain health, low back pain and state-of-the-art technologies tailor-made for expert chiropractic care by managing common clinical syndromes. This course provides attendees with the highest-level education validated through extensive research and proven techniques Dr. Murphy has perfected through not only running his full-time practice but how he lives his daily life.

Some of the topics of discussion during this seminar will include:

- \* A breakdown of the Essential Eight factors/habits that improve health, reduce the risk of health problems that would otherwise require provider interventions
- \* a summary of mechanical integrity – the importance of mechanical integrity with an emphasis on inflammation, fibrosis, and mechanical neurology
- \* An outline of the importance of blood flow as the key component of human physiology, with an emphasis on mitochondrial ATP production
- \* The relationship between mitochondria, free radicals, ATP, cytochrome c oxidase enzyme, and laser proton therapy
- \* A protocol for brain function: trauma, degenerative, vascular
- \* A demonstrated protocol for chronic low back pain, an integrated protocol for scar tissue and the fibrosis of repair, and how to apply a protocol for acute whiplash

**Dan Murphy, D.C., DABCO**, graduated magna cum laude from Western States Chiropractic College in 1978, and has more than 40 years of practice experience. He received his Diplomate in Chiropractic Orthopedics in 1986. Since 1982, Dr. Murphy has served as a part-time undergraduate professor at Life Chiropractic College West, where he is currently teaching classes to seniors in the Management of Spinal Disorders and Spinal Pathology/Neurology. He has also taught post-graduate classes for Life Chiropractic College West, Los Angeles Chiropractic College, Life University (Chiropractic), Logan Chiropractic College, Palmer Chiropractic College, Cleveland Chiropractic College of Kansas City, University of Western States and Northwestern Health Science University. Class topics included biomechanics of vehicular collisions, biometrics of spine trauma, biomechanics of pediatric vehicular collisions, soft tissue injury and repair, pain and proprioceptive neurology, the management of spine and spinal related disorders, and clinical nutrition. He has taught more than 1700 postgraduate continuing education seminars, including classes in the United States, Canada, Australia, France, England, Portugal, Ireland, Italy, Greece, New Zealand, Spain, Panama, South Korea, and Peru. Dr. Murphy has been a contributing author to several books and has written approximately 90 quarterly columns in the American Journal of Clinical Chiropractic. From 2003-2009 Dr. Murphy was the Vice President of the International Chiropractic Association and was honored to be chosen as “Chiropractor of the Year” 2009-2010. Also in 2014 he was awarded a lifetime achievement award from the International Association of Functional Neurology and Rehabilitation.
